AT ASHBURY IMAGES, YOUTH INTERNS RECEIVE HANDS-ON TRAINING IN SILK SCREENING PRODUCTION AND LEARN ABOUT PROMOTIONAL PRODUCT TRADE FROM OUR EXPERIENCED STAFF.
